Ongoing Developments NOTED that the Individual Hospital Reports are due to be released. SM also NOTED; NIKTT - progressing well BEAT CKD - there will be an interesting evolution with the collaboration due to the program grant stopping at the end of this year. ANZOD – continues as a critical source for the Organ and Tissue Authority (OTA). A formation of an ANZOD specific Working Group is currently in the works. Funded by OTA to produce a report regarding the Cardiovascular Transplant Registry which has been done SAHMRI – there has been an increasing consolidation in the registry space with 3 other main registries. SM is a co-chair of a Registry Special Interest group at ACTA, who hosted a registries day at the ACTA Annual Scientific Meeting.
