Compliance Statement

The organisation remains under the business name ANZDATA (Australia and New Zealand Dialysis and Transplant Registry) and ANZOD (Australia and New Zealand Organ Donation Registry) trading under the auspices of the SAHMRI (South Australian Health and Medical Research Institute) ABN 54 141 228 346.

Project materials remain in use in accordance with the current funding agreement and service provision continues to occur as per agreed timeframes.

Highlights During the Reporting period

- All annual survey data, for 2019 reporting, was received by July 2020 from Aotearoa contributing kidney dialysis and transplanting units. Of the 12 contributing units, 50% (6) completed survey data prior to the survey return deadline, all these used electronic data entry as the chosen method of data submission. Three units chose to submit data by paper forms and focus for the forthcoming survey will be to encourage these units to transition to electronic data collection or file transfer.

- The Registry performed the annual data lock in September 2020 enabling analysis and reporting to occur within 9 months of the survey period end (2019)
- Individual Hospital Reports were disseminated in December 2020. These are separate reports produced on patients receiving dialysis and those with a kidney transplant cared for in the specific centre, over the last 5 years (to end 2019). For hospitals where transplants are performed, a further report is produced including the outcomes of kidney transplants performed by that centre. Previously these have been distributed directly to renal units. Following a recent review of practice in this area, this year an additional copy was circulated to the direct to hospital/district CEOs. The expectation is that these may be useful in institution-wide safety and quality reporting processes.

- Ongoing monthly reporting on end stage kidney disease (ESKD) incidence and quarterly reporting on key performance indicators (KPI's) of vascular access and peritonitis rates were disseminated to renal units.
- In November 2020, the Advisory Committee agreed (at the annual virtual face to face meeting) to adopt and report on an expanded suite of KPI's that would further compliment the Individual Hospital Reports. In Aotearoa New Zealand these are planned to be delivered to Head of Renal Units, NRAB and District Health board Chief Executives, with a recommendation to submit to the relevant patient safety and quality committee. To progress this work, a KPI Working Group is to be formed and will support the ANZSN Clinical Policy and Advisory Committee in relation to ongoing development and monitoring of a coordinated Nephrology KPI program.
- Continued data capture and reporting of organ donation and transplantation activity with NZ's Organ Donor Agency and Paired Kidney Program on Living Kidney and Deceased Solid Organ Donation.
- Ongoing collaboration with NZ Organ Donation Agency and NZ Blood Service. With the transition of the NZ Organ Donation Agency under the governance of NZ Blood Service the expand the Data Transfer Agreement to enable data capture specific to wait listing, donor and recipient enrolment, registration and test results was appraised and expected is expected to be updated in the new reporting period.
- The 43rd ANZDATA Annual Report was prepared and published by chapter from October 2020. Chapter 9 - Aotearoa New Zealand and Chapter 11 - Kidney Failure among Māori in Aotearoa New Zealand were drafted and review and published 2021. This was supported by the Aotearoa NZ Working Group.
- The Registry has continued working with the "TEACH-PD" NZ local trial sponsor, the University of Otago and NZPDR to progress the data linkage work. With this trial now in the recruitment phase
- Ongoing development of NZ specific scope of activities under the leadership of the ANZDATA NZ working group.
- The Registry's New Zealand Working Group continues to also engage the Māori Research Committee when required, for review of NZ specific requests the Registry receives.

Analytical Support for NZ reporting

Responding to requests for assistance with projects and enquiries for additional or new information continues. Projects including New Zealand data are circulated to the Registry’s New Zealand Working Group and, in some cases, the New Zealand Renal Advisory Board when required for their input.

Figure 1 Requests by Month for Projects including New Zealand Data – Jan 2019 to Dec 2020

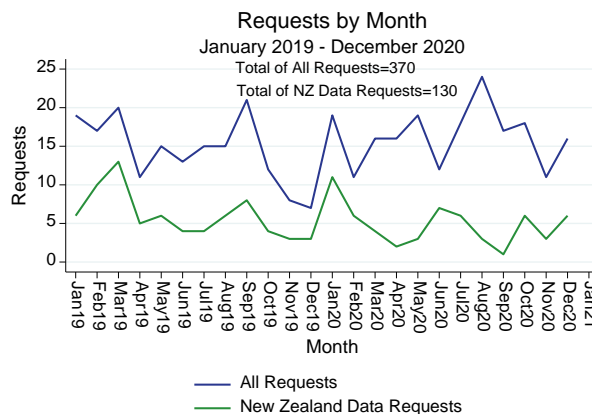


Figure 2 Requests by Month for Projects from New Zealand Requestors – Jan 2019 to Dec 2020

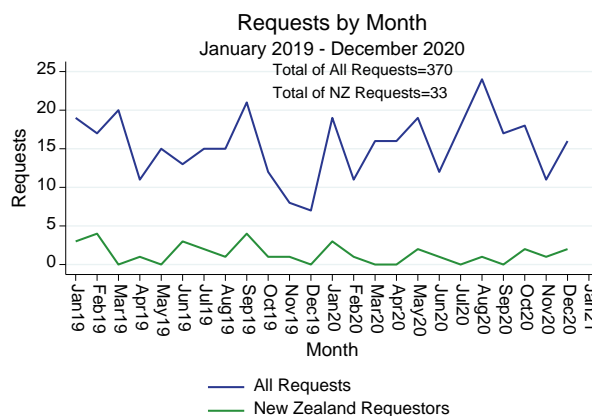


Figure 3 Requests by Quarter for Projects for only New Zealand Data – Jan 2019 to Dec 2020
